### 6. APPROVE PEOPLE FOR PEOPLE CHARTER SCHOOL HEALTH AND SAFETY PLAN

People for People Charter School had prepared an original Health and Safety Reopening Plan for the 2020/2021 academic year in response to Governor Wolf Reopening Process for the Commonwealth of Pennsylvania (in response to the COVID crisis). The original plan was reviewed and approved by the PFPCS Board of Trustee prior to being published on the School's website; and the School's initial reopening.

The Plan provided for the Board's review is a modification and mark up of the original Plan. It has been revised for the intended operation of 2021-22 for People for People Charter School which is still under the heavy influence of COVID-19, a continued health risk to our community.

Upon the Board review and approval the modified language will be inserted into the original Plan and posted on the website as soon as practical.

Reminder to the Board of Trustees and School Senior Administration, the Health and Safety Plan is a living document and as COVID-19 related guidelines from the state, county, municipal, and CDC are continually being revised and updated, future revisions and modifications may be necessary.
