Westchester Environmental appreciates the opportunity to present this proposal for Lead in Water Testing for your district.

## Scope of Work: Lead Water Sampling

- 1. The locations of all sampling points are to be pre-determined either by the School or the Testing Company. The sampling event includes an estimated total of 10 sample locarions. First daw and flush samples will be collected. First draw samples will be analysed. Flush samples will be analysed if corresponding first draw exceed the lead limit
- 2. School district staff will identify all locations to be tested where water is consumed.
- **3.** At the time of sampling, one (1) first draw water and 1 flush sample will be collected from all the predetermined locations.

- **4.** No water should be discharged from these locations for a period of time less than 8 hours and not greater than 18 hours prior to the sample collection
- **5.** All sample collection will be completed by experienced sampling teams of trained technicians.
- **6.** All the samples will be transported, with a secure Chain of Custody, to a Pennsylvania DEP certified Laboratory for analysis. Westchester Environmental will coordinate all lab work including bottle orders and prepare all sample labels and chain of custodies.
- 7. All water samples will be tested for lead content via EPA 200.8 method.
- **8.** Unless otherwise specified, all samples will be analysed with a standard turnaround time of 10 working days.
- **9.** Westchester Environmental will perform a preliminary review of all data from lab prior to submission to the district.
- **10.** A report will be furnished which will summarize the collection activities, sample results, comparison of results to lead action limit, methods and QC summary, and recommendations.

## Fee Schedule:

The fee schedule is based on the following:

- 1. An estimated total of 10 sample locations
- 2. The sampling of the schools will be completed in a one day event.
- 3. All labor, transportation, expenses, lab analysis/data review, preparation of sample labels and chain of custodies and report submission.
